- *All claimants are requested to provide information to liquidator, in case, the claim is partly or fully satisfied by virtue of recovery from or settlement with third party
- *Operational Creditors, Employees, Workmen, and Govt creditors may participate and vote in SCC through their representatives
- *Govt creditors are requested to inform liquidator the names of their respective representatives of their class
- *The Above List has been uploaded on Company's website for access to stakeholders
- *Claimants are requested to provide pending information on priority basis so that list may be modified and updated list may be filed at hon'ble Adjudicating Authority
- *Related Party Claimants may only participate (and not vote) in the meetings of Stakeholders' Consultation Committee once respective claim is admitted, fully or partly
- *IFCL, by virtue of not relinquishing security, is requested to provide further course of action qua section 52; accordingly, it is not the member of SCC and not given vote rights
- *Status of Claimant being secured or unsecured is qua the security/assets/property of corporate debtor only
