**Subject: Request for granting of 60 days more time for submission of quarterly financial results for June, 2019 ended quarter**

Dear Sir,

This is with reference to submission of financial results for the quarter ended June, 2019. As intimated earlier, we have to inform you that the Company is in the process of Corporate Insolvency Resolution Process (CIRP) under the provisions of Insolvency and Bankruptcy Code, 2016 and Mr. Navneet Kumar Gupta has been appointed as Resolution Professional (RP).

Further, as per regulation 15 (2A) and (2B) of SEBI (LODR) Regulations, 2015, the provisions as specified in regulations 17 to 21 shall not be applicable during the insolvency resolution process period. Due to same, the Board is suspended and the powers of the Board rest with the IRP.

Further, the Company has many subsidiaries including overseas subsidiaries and various sites in India and even some foreign sites and also having some associate companies and joint ventures, so considering the scenario in which the Company is operating, it is very challenging and requires more time in collecting and processing data from these locations. We are doing our best to get all the data but it seems that the Company will require at least 60 days more time to prepare financial results for the quarter ended June, 2019 and file the same to the Stock Exchanges and publish the same in the Newspapers.

In view of the above you are kindly requested to give 60 days' more time to file the quarterly financial results with the stock exchanges and to publish the same and not to levy any penalty or enforce any penal action against the company.

The above may be treated as a disclosure pursuant to Regulation 30 of the LODR Regulations.
